The following new planning applications were considered and comments agreed to be sent to Teignbridge District Council as the Local Planning Authority:

1975.1 **APPLICATION REF:** 17/00761/CAN - Teign Lawn, Forder Lane

> PROPOSAL: Prune one yew (T17) to give 1 metre clearance from telephone line, fell four pine

> > trees and remove two lower branches from one Monterey cypress (T3).

Following discussion, consultation with the applicant and hearing the opinion of the Parish Tree Warden it was proposed by Cllr. Lambert, seconded by Cllr. Davey, agreed unanimously and therefore **RESOLVED** to submit the following comment:

> **PROPOSAL:** Detached dwelling and garage with private access drive

> > Following discussion it was proposed by Cllr. Davey, seconded by Cllr. Bailey,

agreed unanimously and therefore **RESOLVED** to submit the following comment:

PC COMMENTS: Bishopsteignton Parish Council feel the proposals are gross overdevelopment of

> the site with an insufficient provision for onsite parking. They would strongly recommend that a highways officer conducts a site visit to reassess the existing and proposed vehicular access. There are additional concerns of loss of light for

and overlooking of neighbouring properties.

BPC are to liaise with District Councillor. T. Golder to suggest this application

becomes category B should the delegated officer be of mind to approve.

of neighbouring properties,..'.
