#### 2177 RATIFICATION OF MINUTES

#### 2178 RECOMMENDATIONS

BPC C&R Committee recommend BPC adopt the latest draft Terms of Reference for this committee, BPC.TR.CR.1807.02 (Appendix A) which includes the addition of new committee members Cllrs. Merritt and Benham. It was proposed by Cllr. Cawthraw, seconded by Cllr. Cahill for this recommendation to be adopted. Agreed unanimously therefore **RESOLVED.** 

#### 2179 POLICE REPORT

The following crimes were reported; these occurred within the period 02.07.18 to 04.08.18.

- Theft Allegation of items of jewellery taken by a family member following a death in the family. Difficulties in proving ownership mean that no investigation can be undertaken. No further action (NFA).
- Theft Online purchased item apparently delivered to incorrect address. Online company dealing with internally.
   NFA
- Theft Small amount of cash taken from a safe at a residential/care home over a period of time, during which numerous people would have had access. Insufficient evidence to proceed. Money reimbursed to victim by the home. NFA
- Theft Jewellery 'possibly' stolen from resident of a residential/care home. Victim confused and unable to confirm how long ago the items were present. Investigation impossible. NFA

#### 2180 DISTRICT COUNCILLOR REPORT

It was resolved by this committee that an untidy land notice would be delayed for 6 months due to the imminent sale of the land; originally the committee proposed 12 months but Cllr. Golder secured this reduced period before reviewed again by planning officer.

Peart expressed his concerns about the Parish Councils application via the Neighbourhood Highways Officer to install double yellow lines at the junction of Littlefields which was considered recently by the DCC Highways and Traffic Order Committee (HATOC). He felt it was inappropriate and he'd consulted residents who agreed.

Golder had conducted a site visit and understood and sympathised with Mrs. Kyte's comments adding the value of the twinned design of these bungalows; he also reminded that loss of view was not a valid planning objection. PC Comments: BPC have concerns the proposed development will cause a loss of natural light and privacy to the

neighbouring property. Proximity of the shared boundary is already close and the proposed increase to

the roof height could be overbearing.

consider the potential for overlooking; remaining mindful these properties are reverse level living accommodation. Potentially, privacy screening for the sides of the balcony, particularly on the east,

could be a condition imposed.

Proposal: Variation of condition 2 on planning permission 14/01779/FUL (conversion of barn to two dwellings) to

amend external appearance and addition of a patio area at the rear of the properties.

introduction of larger Velux windows which are not obscured glass. The council fully support the objection raised by Mr & Mrs. Avenall, of 36 Bishops Avenue and wish to reiterate the points they have

made.

## 2134 BISHOPS AVENUE CAR PARK TRANSFER

The legal document had been reviewed by all members and was as expected. It was proposed by Cllr. Cawthraw, seconded by Cllr. Nicholson, that the TR1 be signed by the Chairman and Vice-chairman and returned allowing the solicitor to complete the transaction. Agreed unanimously therefore **RESOLVED.** 

The Chairman suggested a working party of nominated members to move the car park development forward. This was proposed by Cllr. Nicholson, seconded by Cllr. Cawthraw, nominated were Cllrs. Davey, Cahill, Lambert & Benham. Agreed unanimously therefore **RESOLVED**.

## 2135 NETWORK RAIL ASSETS: Disposal of Luxton Steps river beach

The possibilities of the loss of this land for public amenity was discussed and a cause of concern.

It was proposed by Cllr. Nicholson, seconded by Cllr. Cawthraw, that a letter be sent to Network Rail, copied to Mr. Graeme Smith, TDC Coastal Officer, and the Teignmouth Harbour Master, to establish the exact details of the disposable asset reporting the community use of the land and to highlight this to the prospective purchaser. Agreed unanimously therefore **RESOLVED**.

- .02 Fore Street & West Street Bin Problems Cllr. Morgan reported that a decision had been made by the District Council, in conjunction with the County Council, for no further action to be taken regarding the official complaint; therefore, no further action for BPC.
- .03 **Teign Estuary Trail** Cllr. Benham expressed concern that the TET project could lose momentum if not pursued regularly by BPC and agreeing a route needs to be the first step before any finance can be established. She proposed a meeting with Roger North, DCC TET project manager, and for Cllr. Peart & Cllr. Golder to be invited. This proposal was seconded by Cllr. Cahill and agreed unanimously therefore **RESOLVED**. Clerk to contact Mr. North to arrange.
- .04 Removal of disabled parking bays at West Town Meadows Cllr. Nicholson questioned the proposal to remove these marked bays; is it be all three? She stressed how residents are concerned this may encourage parking close to the adjacent entrance/drive way which will reduce visibility. They ask if there are plans to reinstate the double yellow lines which were removed to provide the disabled bays. Clerk to liaise further with the NHO.
- .05 **Happy Valley enforcement response** Cllr. Cahill asked if enforcement have taken any action following BPCs report of unlawful development activity in Happy Valley. The clerk had not had a response but would chase this matter.
- .06 **Highways Liaison Meeting** Cllr. Merritt gave a brief summary of the meeting held 02.08.18. Clerks notes would follow as soon as possible.
