#### 2176 COUNTY COUNCILLOR REPORT

Cllr. Peart reported news from Devon County Council including details of a conference about food waste and recycling. A survey of 1800 black bins revealed 60% of the contents 30% of their contents should be recycled, 30% was food waste. Support from Town and Parish Councils to encourage recycling would be greatly appreciated.

He reported that a program of structural highways works was ongoing but making good progress, gully clearing around the county was 60% complete, and the majority of grit bins were filled ready for the winter service.

Cllr. Benham asked if a bin could be installed at Salcombe Dip, A381, as drivers will often stop there to eat/drink but there is currently nowhere nearby to dispose of rubbish. As this is a matter for the district council the clerk would make contact to ask if this can be arranged.

#### 2177 DISTRICT COUNCILLOR REPORT

Cllr. Golder reported that a Public Spaces Protection Order was being considered further by the Overview and Scrutiny Committee. This will have an effect on how many dogs can be walked at once, on-spot fines for not being equipped to pick up dog mess and dogs being walked on a lead on footpaths adjacent to the highway.

#### 2182 MEMBERS REPORTS

- .01 HALLS FOUNDATION: Cllr. Morgan wished for the report from the last meeting of the Halls Foundation to be noted. Unfortunately the document had been sent in a format which could not be read. Cllr. Morgan to resend.
- .02 **REMEMBRANCE POPPIES:** Cllr. Grimble wished for thanks to be sent to Mrs. Caroline Thornton for initiating and organising the huge community effort to transform the Fore Street railings with knitted poppies. This motion was seconded by Cllr. Morgan and agreed unanimously. Therefore **RESOLVED** for the clerk to send thanks from BPC.
- .03 **FLY TIPPING:** Cllr. Nicholson reported recent fly tipping on Ideford Common, near the car park which contained asbestos. This had been report to TDC.
- .04 **TEIGN ESTUARY TRAIL:** Cllr. Benham raised concern that contact with DCC was not maintained between meetings; she felt more pressure should be place on DCC to make progress and report back to BPC. Cllr. Merritt assured her the matter was constantly being pushed by all relevant parties. A meeting was being arranged for before the end of 2018.
- .05 **HIGHWAYS:** Cllr. Merritt reported that a meeting was arranged for 13.11.18 with representatives from DCC Highways, Cllr. Peart and Cllr. Lambert & Cllr. Merritt from BPC to discuss all ongoing or arising Highways issues; Including the removal of the gritting service and installation of new grit bins. Cllr. Morgan expressed concern the bus service may be withdrawn if drivers experience difficulties.

### 2183 CLERKS REPORTS - The clerk reported the following updates:-

- .01 **PLAYGROUND IMPROVEMENTS:** New swing ordered and coming soon, new poles and climbing rocks too; all at Cockhaven close. A site meeting was scheduled to discuss border fencing with the neighbour.
- .02 **OFFICE RELOCATION:** Physical part almost complete. Thanks to BCCMC and BPC for allowing and facilitating the move. Some minor changes to the HOT which is now with the appointed solicitor.
- .03 **MEMORIAL:** Asked BPC to consider a memorial for Mrs. Knapman who served as Parish clerk for 24 years. It was agreed for the clerk to liaise with Mrs. Gardiner, Jeans daughter, about the family's plans for memorial and their preference for BPC action. For discussion at a future meeting.
