.02 District Councillor Report

Cllr. MacGregor circulated the following report to members prior to the meeting:

1) Bin collections are rescheduled due to the double bank holiday w/c 30th May. The altered dates for residents from their usual bin collections is found on this link.

2) Council Tax Rebate. Around 33000 households in council tax bands A-D have received their payment of £150. This essentially includes the tranche that pay their CT by Direct Debit. Around 13000 letters are being sent out to

non-DD households outlining the two options, which are payment to a bank account, or payment to their council tax account.

- 3) The decarbonisation project at the three leisure centres has been officially recognised. TDC has been shortlisted for the Large-Scale Project award at the SW Energy Efficiency awards, in partnership with Leisure Energy.
- 4) Autumn Covid Booster advice issued. A link to the Joint Committee on Vaccination and Immunisation advice: https://www.gov.uk/government/news/jcvi-provides-interim-advice-on-an-autumn-covid-19-booster-programme
- 5) Bakers Yard application was refused on DCC Highway safety grounds. It is likely that the application will be appealed. The application process highlighted a very clear need for careful consideration when creating neighbourhood plans. Despite being outside the settlement limit, the officers backed the application on the grounds BNP had included a need for development at the site.
- 6) The NA To Torbay cycle route funding was passed at Full Council recently. This despite the Teign Estuary Trail being sufficiently advanced to have a planning application submitted. The reason this is being prioritised is down to there being 2 tier one councils pushing for funding through levelling up funding routes. TDC is effectively being dragged along as a result. I will be trying to establish the likely impact on future funding for TET at the next full council.
- 7) Decarbonisation work at Forde House is about to recommence. Additional funding has been agreed to meet increased costs associated with inflation on materials and labour as well as exiting from the administration process with Midas. This money will not be from borrowings as with previous contributions from TDC.
- 8) The new council chair is Cllr Charles Nuttall, with vice chair Cllr Chris Clarance.
- 9) NA redevelopment on Queen Street is the subject of a consultation. - 10) The Council Leader announced at the last full council that the Future High Street Fund and other large projects are to be reviewed in light of the spiralling costs to deliver and the limit of funding available.

Following a newspaper article Cllr. Grimble asked why recently granted funding was awarded to the Cycle trail between Newton Abbot and Torquay rather than the Teign Estuary Trail (TET). Cllr. MacGregor expressed his disappointment in this step and indicated that the successful trail was shovel-ready; a term which includes certain criteria which TET does not yet meet such as all land purchasing is complete. In addition, the tier of the applying county will have has an influence; both Devon County Council and Torbay Council are tier 1 whereas Teignbridge District council is tier 3.

Cllr. Grimble asked for an update on the planning application for 2 great Furlong, reporting it has disappeared from the TDC planning portal. Cllr. MacGregor to investigate and report back.

2819 BISHOPSTEIGNTON PRESCHOOL

Members consider the request from the management of Bishopsteignton Preschool (Bishopsteignton School) for financial support from the Parish Council, as detailed in the previously circulated but private and confidential appendix (*in accordance with BPC Standing Order 11.c.*). Mrs. Fuell, School Business Manager, and teacher Miss. LeBalleur, were in attendance to answer any queries from parish Council including why Devon County Council cannot take over, where reserves previously held had been used, and that a combination of covid and low birth-rate have caused pupil intake to fall whilst not being able to make changes to staffing structure mean more was being spent.

Following much discussion, it was proposed by Cllr. Shaw, seconded by Cllr. Head, that BPC agree to earmark a reserve of £7,500.00, which in part or wholly may be used by Bishopsteignton Preschool during the financial year 2022-23 as a back-stop fund to enable to continuation of the provision of a preschool in the community of Bishopsteignton. FOR: 8, AGAINST: 1, therefore RESOLVED.

Furthermore, it shall be noted this is a one-off fund offer and additional financial support from Bishopsteignton Parish Council cannot be guaranteed in the future. To strengthen this agreement and the relationship between the Parish Council and Bishopsteignton Preschool a report which will clarify
