O1. APP REF: 22/00971/LBC - Clanage House, Clanage Street Bishopsteignton Devon TQ14 9QS
PROPOSAL: Gable end repair of delaminated render with traditional lime render

02. **APP REF:** 22/01352/TPO - 12 Murley Grange Bishopsteignton Devon TQ14 9TX **PROPOSAL:** Fell one diseased Turkey oak

It was proposed by Cllr. Gateshill, seconded by Cllr. Grimble, that the following comment be submitted. Agreed unanimously, therefore **RESOLVED.**

BPC COMMENT: Further to consultation with the Parish Tree Warden the Parish Council have no objection to the felling of this Turkey Oak however would encourage the applicant to plant another tree of similar species and stature.

03. **APP REF:** 22/01338/CLDE - Green Oaks Forder Lane Bishopsteignton Devon TQ14 9RZ **PROPOSAL:** Certificate of lawfulness for existing occupancy of the property as an independent dwelling in breach of agricultural occupancy condition

It was proposed and seconded that no comment be made to the application but a letter expressing concern at the handling of this matter over the years, that the application is too late for appropriate

action to be enforced. This is to be set to the relevant TDC planning officer, copied to Cllr. MacGregor for his information. Agreed unanimously therefore **RESOLVED.**

2846 TEIGNMOUTH TOWN COUNCIL NEIGHBOURHOOD PLAN REGULATION 14 CONSULTATION

Members had reviewed the documentation prior to the meeting. It was apparent that a great deal of work has gone into preparing the plan and members of the plan steering group should be congratulated for the results which is very comprehensive. There was no aspect of the plan or it's content which stood out as requiring opinion from Bishopsteignton Parish Council.

2847 OTHER MATTERS RAISED

- .01 The clerk reported that new parish councillor M. Smith has expressed his wish to join the planning committee. Cllr. East added his interest to join. Both appointments were acceptable to present committee members therefore it was proposed, seconded, unanimously agreed and RESOLVED.
