02. **APP REF:** 22/01434/FUL - Fair Isle 39 Teign View Road Bishopsteignton Devon TQ14 9TR **PROPOSAL:** Erection of a dwelling

Following a lengthy consideration, during which members of the public expressed both support for and various objections to the proposal, it was proposed by Cllr. Grimble, seconded by Cllr. Gateshill, that the following comment be submitted. In addition, that a category B request be submitted to TDC for their consideration. FOR: 5, AGAINST: 1, therefore **RESOLVED**.

- **BPC COMMENT:** Bishopsteignton Parish Council object to the proposal due to the topography, size and shape of the site and its proximity to neighbouring properties, particularly to the south, with the potential for overlooking and loss of privacy. Further concern is given to the design of the proposed building with particular reference to the central 'tower' and how this will impede the ancient view of the Teign Estuary and beyond from the north of the site.
