outline planning permission 20/01321/OUT (Outline - demolition of existing scout meeting hall and erection of up to two dwellings (all matters reserved for future

consideration)

**BPC COMMENT:** No objection provided the officer is satisfied with the height of the boundary fence,

plan in accordance with building control monitoring and guidance.

PROPOSAL: BSHP025, Holm Oak: Fell

Following discussion, during which the clerk reported the opinion of the parish tree warden, Mr. Peter Hepworth, had been sought. Mr. Hepworth agreed with the proposed felling as the tree is diseased and

## 2958 TEIGNBRIDGE TOWNS & PARISHES PLANNING FORUM

On behalf of Bishopsteignton Parish Council Cllr. Gateshill attended, and chaired, the most recent forum, held 21.06.23. He gave a brief verbal report of progress and the information provided in a slideshow by Ros Eastman, Business Manager – Strategic Place. The overall feeling of forum members is to re-establish the Teignbridge Association of Local Councils (TALC). As before, these meeting would take place in the chambers at TDC, a more suitable location for all attending. The clerk of the forum meeting has written to TDC Councillor Linda Goodman-Bradbury requesting this action, awaiting response.

## 2959 BAKERS YARD DEVELOPMENT

Cllr. Grimble reported intense activity at the site. Cllr. Hanafin, as a neighbour to the site confirmed this and stressed the problems raised including the creation of excessive dust and damage to personal property. The clerk reminded them to report all concerns to Teighbridge as the Local Authority responsible for Environmental Health, Building Control, and Planning Enforcement.

The clerk advised a revised application was expected imminently, and this will be circulated to members as soon as details are received.
